
Important Information about your Electricity Sources

("Hudson Energy") is required to provide its customers with Environmental Disclosure Information quarterly under Section 16-127 of the Electric Service Customer Choice and Rate Relief Law of 1997 and the rule of the Illinois Commerce Commission, 83 III. Adm. Code 421.
